Application Process for the UNSW Medicine Master of Public Health (International)

1. Submit completed Expression of Interest form, up to date CV, copies of all academic transcripts/testamurs, proof of english level to drashwin_k@medvarsity.com by **16 June 2017**. We highly recommend all applicants submit the EOI well before the final deadline to avoid any delays with the assessment of their application.
2. Your expression of interest will then be assessed by UNSW staff;
3. You will be advised within 1 week if you meet the requirements for the UNSW Master of Public Health (International) degree;
4. If you do meet the requirements, you will need to submit an official application via [UNSW Apply Online](#) website.
5. An official offer letter will be emailed to you – please allow 2-4 weeks for processing;
6. You will then be required to accept the offer and enrol in your courses for the relevant semester.
